In response to your questions, what I can tell you is that the file currently remains open. It was forwarded to Crown Counsel for review in July 2008, but we have not been advised on when that review will be completed, or whether any charges will be approved. There have been no decisions made on any potential Police Act matters pending the resolution of the Crown review of the investigation. Once the Police Act review has been completed, the file will be sent to the Office of the Police Complaints Commissioner.

I am writing in response to your April 3, 2009 letter requesting information regarding the coroner investigation into the death of Paul Boyd.

This death was the result of an incident involving members of the Vancouver Police Department and is set for review at the Office of the Chief Coroner by a committee consisting of the Chief Medical Advisor, the Director of Regional Operations and the Chief Legal Counsel. The committee will review the death of Mr. Boyd and provide advice respecting the authority of the Chief Coroner to direct that an inquest be held.

The coroner investigation is ongoing and none of the information collected will be disclosed to the public until the investigation is complete or a public inquest is held.
